MISCELLANEOUS PROVISIONS

Warning ALL participants must read

An equine activity sponsor, equine activity participant, equine professional, veterinarian, farrier, or other person is not liable in damages in a tort or other civil action for harm that an equine activity participant allegedly sustains during an equine activity and that results from an inherent risk of an equine activity.

An equine activity participant or the personal representative of an equine activity participant does not have a claim or cause of action upon which a recovery of damages may be based against, and may not recover damages in a tort or other civil action against, an equine activity sponsor, another equine activity participant, an equine professional, a veterinarian, a farrier, or another person for harm that the equine activity participant allegedly sustained during an equine activity and that resulted from an inherent risk of an equine activity.

I hereby warrant that I am a willing participant of equine activities at the event known as _____ located at

_____ OHIO on _____ 20 and further release all equine activity sponsors, equine activity participants, equine professionals, veterinarian, farrier, or other persons for my responsibility to:

- (a) Inspect all tack and equipment prior to their use, regardless if owned, borrowed, or loaned by others equipment for proper and safe condition.
- (b) Completely disclose my ability to safely engage in the equine activity or to safely manage the equine based on my representations, and authorizations of my ability. I accept full responsibility for damages or harm caused by my failure to safely engage in the equine activity or to safely manage the equine, and that failure proximately causes the harm involved.
- (c) I agree that harm may be proximately caused by a dangerous latent condition of the land on which or the premises at which the harm occurs, I accept responsibility to inspect the premises, and make known to the equine activity sponsor and by continuing participation I warrant any and all known conditions have been shown, and identified prior to participation.

EXCEPT AS:

- (d) An act or omission of an equine activity sponsor, equine activity participant, equine professional, veterinarian, farrier, or other person constitutes a willful or wanton disregard for the safety of an equine activity participant and proximately causes the harm involved.
- (e) An equine activity sponsor, equine activity participant, equine professional, veterinarian, farrier, or other person intentionally causes the harm involved.

I AFFIRM, I AM RESPONSIBLE AND LEGALLY REPRESENT THE MINOR KNOWN AS _____ . BY SIGNING I AGREE THAT I HAVE READ AND EXPLAINED TO THE MINOR ALL INHERENT RISKS ASSOCIATED WITH AN EQUINE ACTIVITY, I UNDERSTAND AND ACCEPT ALL CONDITIONS ABOVE, AND THAT HE/SHE CAN ONLY PARTICIPATE UNDER MY DIRECT SUPERVISION.
