

# Midrealm Internal Letter of Acceptances and Returns

**February 13, 2017**

Greetings I send, Estelle Rouge Scarpe, unto the Midrealm College of Heraldry. Here follows is the Midrealm Letter of Acceptances and Returns for the Internal Letter of Intent dated January 7th, 2018.

**1: Auenwald, Shire of** - New Device

*Azure, a beaver passant guardant within a laurel wreath Or, a chief nebuly argent.*

**Decision: Forwarded to Laurel.** Submission redrawn with a more closed wreath and permission given to use redraw by submitter.

**2: Caitilin inghean Neill** - New Augmentation of Arms

*Purple, in saltire an arrow argent and a quill pen Or, a bordure argent, and as augmentation in base a quill pen palewise Or.*

**Decision: Returned for Redesign:** This is being returned for violation of SENA A.3.D.1 "Clarity of Charge Groups". The quill pen is too small to identify, but if made larger, would blur the line between secondary and primary charge groups. The most simple solution to this would be to put the augmentation on a secondary charge, such as a roundel or an escutcheon, as the submitter chooses. The submitter is advised to redesign this submission and resubmit to Escutcheon.

**3: Ellisif Auðinardóttir** - New Device

*Argent, a cat sejant guardant and on a chief nebuly purple three hearts Or.*

**Decision: Forwarded to Laurel.**

**4: Emer Atzinger** - New Device

*Quarterly gules and argent, two foxes courant argent.*

**Decision: Returned for Conflict.** - Conflict with Deirdre Thomson (October of 2010 via the Middle): Per bend vert and sable, two foxes courant argent. 1 DC for the field, nothing for the forced change of arrangement.

- Conflict with Sabina of Borthwick (October of 2002 via Aethelmearc): Per pale gules and azure, in pale two wolves passant argent. 1 DC for the field, nothing for the forced change of arrangement.

**5: Gwyneth Cole** - New Device

*Per pale argent and vert, a trillium counterchanged.*

**Decision: Forwarded to Laurel.**

**6: Hrothgar Bjolfsson** - New Device

*Sable, enfiled on a viking sword proper, between two wolf's heads ululant couped and addorsed argent, three annulets Or.*

**Decision: Forwarded to Laurel.**

**7: Katalena Ivaniaia zhena Shishova** - New Name Change

*Old Name: Kateline Eliot, to be retained as an alternate name.*

**Decision: Forwarded to Laurel.**

**8: Laurentius Le Rous** - New Device

*Quarterly gule and argent, a fess chequy Or and azure between two fish skeletons uriant bendwise sinister argent and two anchors bendwise sinister gules.*

**Decision: Forwarded to Laurel.**
