## 1a: Alaric of Rivenvale - New Name

### **Decision: Forwarded**

“Alaric is cited to A. D. 959 In Bolòs, Jordi & Josep Moran. Repertori d'Antropònims Catalans. (RAC) Barcelona: Institut d'Estudis Catalans, 1994, p. 95. Found in the Proceedings of the 2009 KWHSS under Name Documentation and Evaluation.”

## 1b: Alaric of Rivenvale – New Device

*Gules, in bend two wild boars Or.*

### **Decision: Forwarded**

Change blazon to “*Gules, in bend two boars rampant Or.*”

## 2: Alys Katherine - New Heraldic Title

*Acorn Vert Herald*

**Decision: Forwarded** under name Alys Katharine

## 3: Artúr mac Griogair - Resub Device

*Argent, a manta ray azure.*

### **Decision: Forwarded**

## 4: Artúr mac Griogair - Resub Badge

*(Fieldless) A manta ray azure.*

### **Decision: Forwarded**

## 5: Bethóc MacDonald of Cnoc - New Augmentation of Arms

*Sable, a sun between six mullets of six points in annulo and a bordure Or and for augmentation in base a quill Or.*

### **Decision: Forwarded**

Change blazon to “*Sable, a sun between six mullets of six points in annulo and a bordure Or, and for augmentation in base a quill bendwise sinister Or.*”

## 6: Clarissa de Corvus - New Name Change

**Decision: Forwarded** as Clarissa Corvinus.

Submitter would prefer Clarissa de Corvus, but has approved Clarissa Corvinus if necessary. Clarissa is the Latinized form of Clarisse.

**7: Cole O'Doran – Resub Device**

*Azure, a horned serpent erect and on a point argent, a lzenge azure.*

**Decision: Forwarded**

Blazon corrected to “*Azure, a horned serpent erect and on a point pointed argent a lozenge azure.*”

**8: Dark River, Shire of – New Badge**

*Argent, a ram-horned yak courant proper saddled argent, upon its back a rat rampant sable maintaining in its hands a fireball proper.*

**Decision: Returned**

Armory cannot have maintained charges that maintain charges, and also, since the yak is ram horned, it's a monster, and yak-monsters do not have a proper color. Suggest that it be recolored as black, or horns removed, and the fireball dropped.

“We have no period support for maintained charges which themselves maintain charges. Absent documentation of this arrangement of charges, it must be returned.”

**9a: Duncan Sinclair -New Name Change**

**Decision: Forwarded**

**9b: Duncan Sinclair -New Augmentation of Arms**

*Argent, in chief three fish bendwise contourny in chevron inverted vert and in base a brown bear statant contourny proper, and for augmentation on a chief vert a quill pen Or fesswise.*

**Decision: Forwarded**

**10: Éadaoin Ghormshúileach - New Augmentation of Arms**

*Vert, on a pale argent within a bordure counterchanged a continental panther contourny sable enflamed proper, and for augmentation in chief a quill pen fesswise Or.*

**Decision: Forwarded**

Reblazon: “*Vert, on a pale argent a Continental panther contourny sable incensed proper, overall a bordure counterchanged, and for augmentation on the bordure in chief a quill pen fesswise Or.*”

**11: Edward Archer of Kent - Resub Device**

*Per bend vert and gules, a drawn bow with arrow nocked, an orle argent*

**Decision: Forwarded**

**12: Elophina La Peyra - Resub Device**

*Azure, on a sun Or a dragon displayed sable, and a bordure compony sable and argent.*

**Decision: Forwarded**

July 2017 LoAR, it was ruled that "Absent documentation, we will cease to register any depictions of animate charges displayed with the torso twisted to dexter or sinister as of the January 2018 decision meeting. Note that even an acceptably drawn dragon displayed remains a step from period practice." As this depiction of a dragon "displayed" has the torso turned to dexter, it is returned under this precedent.

**13: Emer Atzinger - Resub Device**

*Quarterly gules and argent, two foxes courant argent.*

**Decision: Forwarded**

Reblazon: "Blazon suggestion: Quarterly gules and argent, in bend two foxes courant within a bordure counterchanged."

**14: Kodran Grimsson i Hrafnskogi - Resub Badge**

*Azure billey argent, an angel argent and a chief ermine.*

**Decision: Forwarded**

Reblazon: "Azure billey, an angel argent and a chief ermine"

**15: Margaret MacLeod of Duntulm - New Augmentation of Arms**

*Sable, a sun between six mullets of six points in annulo Or and for augmentation in base a quill Or.*

**Decision: Forwarded**

Reblazon: Sable, a sun between six mullets of six points in annulo Or and for augmentation in base a quill bendwise Or.

**16: Ragna stórráða Úlfsdóttir - New Alternate Name**

*Hostilia Lupa*

**Decision: Forwarded**

**17: Slany bean Uillic - Resub Device**

*Argent, two rats combatant each maintaining a knife gules.*

**Decision: Forwarded**

**18: Taisiia Volodimirna - New Augmentation of Arms**

*Quarterly sable and gules, an elephant's head cabossed proper maintaining, for augmentation, a quill pen fesswise Or, and in chief three Russian Orthodox crosses argent.*

**Decision: Forwarded** under name Taisiia Volodimerna

Reblazon: "Quarterly sable and gules, an elephant's head cabossed proper and in chief three Russian Orthodox crosses argent, and for augmentation the elephant's trunk maintaining a pen Or."

**19: The Rising Cetus, Shire of – New Branch Name**

**Decision: Returned** for insufficient documentation of pattern and name parts.
