All merchants will be in a common area. Everyone coming in from troll or camping areas to the fighting fields will have to pass by the merchants. Please remember this is an outdoor event and your merchant space will be exposed to the weather. There is no indoor vending. Bring your own sunshade, tent, tables, chairs, et cetera.

Merchant pre-registration is required. A confirmation email or phone call will be made when paid pre-registration is received by the Merchant Coordinator. No confirmation email or phone call means your pre-registration has not been received!

It is strongly recommended you include your site fees with your merchant fees. By pre-registering all your fees, you can move through troll quickly. If you have employees/helpers, consider paying their site fees as well, as they will be required to pay before being allowed to assist you. **Everyone will need to stop at troll to sign a waiver and pick up their site token.**

Space reservation conditions and terms:

Merchants may check in and set up beginning at 2PM Friday, June 19, 2008. Merchants can arrive and set up between 2PM and 10PM on Friday and after 8AM on Saturday. By pre-paying, you can pass through troll quickly. You must go through troll to sign the waiver, get your site token and receive your merchant tag. Your merchant tag will indicate how many 12X12 merchant spaces you have paid for.

You will need to follow the rules of Bertha Brock Park. While Bertha Brocke enjoys the company of your dog, it is your responsibility to keep them leashed at all times. **Disruptive animals will be asked to leave the park.**

Merchants must arrive on site by 11AM Saturday for their reservations to be honored. Any merchant arriving after 11AM risks not receiving his reserved space.

Merchants must be offsite no later than NOON on Sunday. Any Merchant on site after noon Sunday will be subject to the standard Bertha Brock park fees. Any merchant leaving trash on site will not be allowed to vend at this event in the future.

The Autocrat asks that wares for sale be SCA-related. Vendors must agree to remove from display any items objectionable to the Autocrat. Sales of food items are restricted; please consult the Autocrat or Merchant Coordinator if you wish to sell food or any beverages. If you have any questions, please ask. We encourage all merchants to add ambiance to their booths by using colorful table coverings, bringing their signs, banners, etc.

Weapons of any kind cannot be sold to a minor (under 18). Any vendor doing so will be asked to leave immediately. Remember check ID. When in doubt, **do not** make the sale.

Collection and payment of Michigan sales taxes are the merchant's responsibility. The event staff is not liable.

There is no on site security. Vendors are responsible for their own property. The event Staff, the Canton of Rimsholt, and/or the Society for Creative Anachronism, Inc. is not liable for any theft, moving, or damage incurred.

As always, we remind you that **this is an outdoor event.** We have no control over the weather or bugs. The park treats for mosquitoes.

NSF checks. If you pass us a bad check, you must remit a money order for the original check amount and any NSF charges levied by our bank within 30 days of notification. Please note failure to do so will result in our notifying the Kingdom bad checks deputy. Vendors who do not redeem a NSF check will be unwelcome at future Baronial Border Wars.
